NAVIGATING CAMPUS WITH ROAD CLOSURES

Location Information

University of Maryland College Park Adele H. Stamp Student Union 3972 Campus Drive College Park, MD 20742

 Day 1: Stamp Prince George's Room 1211 (1st Floor) & Carroll Room (2nd Floor) for Reception only
Day 2: Stamp Prince George's Room 1211

Please use the instructions below to assist you in navigating campus and accessing the conference room locations given there are a number of road closures due to construction. The live campus map can be accessed <u>here</u>.

For Driving/Parking

Set your destination to Union Lane Garage, College Park, MD 20742. You can enter this address directly into your GPS. The garage entrance is on Field House Drive, **you can ignore and drive around the "Road Closed Ahead" sign before the entrance.** Parking must be prepaid using the ParkMobile app (Download on <u>Apple Store</u> or <u>Google Play</u>), or you can pay at a pay station located near the garage exits. Union Lane Garage parking is \$4 per hour, with a daily maximum of \$20. The garage closes at midnight.

Upon exiting the garage, the Stamp Union will be directly across from you with two visible entrances to the right of the largely printed building letters "S T A M P." **Please walk down toward the right and enter from the second entrance**, where you will see SFARN conference signage to direct you to the appropriate room location.

For Uber, Lyft, etc. drop-off

Set your destination to Union Lane Garage, College Park, MD 20742. Enter campus from the entrance on Stadium Drive and University Blvd. You can enter this address directly into your GPS. **Ask your driver to drop you off at the Stamp Union loading dock entrance on Field House Drive**. This entrance is on the same road as the Union Lane Garage and is directly across from the Bob Turtle Smith Stadium.

Upon entering the building from the entrance near the loading dock, you will see signage directing you to an elevator and again directing you to the appropriate room location.

For Walking or using Public Transportation

Set your destination to Adele H. Stamp Student Union, 3972 Campus Drive College Park, MD 20742, which will bring you to the main entrance of the Stamp Union.

Upon entering the building from the main entrance, you will see signage that will direct you to the appropriate room location.

Instructions to connect to Wi-Fi:

1. Connect your device to the "UMD-Guest" network

2. Open a web browser

3. If the browser doesn't automatically direct you to the login screen then go to the <u>umd.edu</u> website, this will cause the login screen to appear

4. Scroll down to the bottom of the page click on the Red " Already have an account? CLICK HERE" button

5. Type in the username and password for the current date and click login. Remember that all usernames and passwords are in lowercase type.

NOTE: If you receive the "Success" pop-up but don't have internet access try to turn your Wi-Fi off and then back on.
